AN AMENDED ORDINANCE ADOPTING LIMITED RULES AND REGULATIONS RELATED TO THE SALE, POSSESSION AND CONSUMPTION OF LIGHT WINE AND BEER IN THE CITY OF SALTILLO, MISSISSIPPI

WHEREAS, Section 67-3-65 of the Mississippi Code authorizes a municipality to enforce proper rules and regulations for fixing zones and territories, prescribing hours of opening and of closing, and for such other measures as will promote public health, morals, and safety relating to the sale, possession and assumption of light wine and beer.

WHEREAS, the Mayor and Board of Alderman for the City of Saltillo, Mississippi, in the interests of promoting public health, morals, and safety, related to the sale, possession and consumption of light wine and beer as defined by the applicable laws in Chapters 1 and 3 of Title 67 of the Mississippi Code, do hereby exercise that limited regulatory power as expressly provided in Section 67-3-65 of the Mississippi Code.

WHEREAS, any references to light wine and beer (as used collectively or separately herein) shall have the same definition, application and meaning as set forth in Chapters 1 and 3 of Title 67 of the Mississippi Code.

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF SALTILLO, MISSISSIPPI, AS FOLLOWS:

That entities which have a valid permit through Mississippi ABC for the sale and on-premises consumption of beer and light wine shall be allowed to conduct such sales on Sunday, February 13, 2022 between the hours of 1:00 PM and 9:00 PM. That such sales must be limited to on-premises consumption only, and all participating entities must be mindful and use reasonable care in not over-serving customers. That the remainder of the previously enacted city ordinance concerning this subject matter shall remain in full force and effect and the said original ordinance shall revert back, in its entirety, upon the expiration of this limited ordinance, as noted herein.

Section II. Severability, Conflict, Effective Date, and Publication

- (A) Severability. Should any section, clause, paragraph, provision, or part of this ordinance for any reason be held invalid or unconstitutional by any court of competent jurisdiction, this act shall not affect the validity of any other section, clause, paragraph, provision, or part of this ordinance. All provisions of this ordinance shall be considered separate provisions, and completely severable from all other portions.
- (B) <u>Conflict</u>. In any case where a provision of this ordinance is found to be in conflict with a provision of any other ordinance of code of the City of Saltillo, Mississippi, existing on the effective date of the ordinance, the provisions of this ordinance shall take precedence.

- (C) <u>Effective Date</u>. This Ordinance shall become effective, upon publication, on February 13, 2022.
- (D) <u>Publication</u>. The City Clerk is instructed to publish this ordinance one (1) time in the Northeast Mississippi Daily Journal and to obtain proof of publication thereof and record this ordinance in the ordinance book.
