**RE: 2018-2019 FY PROPOSED BUDGET WORKSHOP**

The Mayor and Board of Aldermen met with the Water, Sewer and Street departments to go over the 2018-2019 FY Proposed Budget. There were a lot of questions concerning previous budgets and why there was so much water loss in the city. The proposed water increases of \$15 per minimum bill and \$5 per 1000 over the minimum usage of 2000 gallons was not well received when it was discussed that the minimum bill needed to go up whether or not the city switched to river water. The auditors have been informing us for approximately 3 years that the city was spending it's reserves down in order to meet cost and that we have depleted our reserves without cashing in certificates of deposits that we have on hand. Aldermen Driskill and Grantham suggested that we split up water employees' salaries and that some employees be paid from water, sewer and street. The clerk informed the board that they would only be possible if the work they do is in fact related to the department they are being paid out of. The clerk and department heads will revisit the proposed budget and come back with numbers at a later meeting.
