On the motion of Copey Grantham, seconded by Donald Cullum, and by an affirmative vote of all present to approve the agenda items with the following addition to advertise bids for meter & valve for water switch to NEMSRW.

On the motion of Copey Grantham, seconded by Craig Sanders, and by an affirmative vote of all present to approve the minutes for August 7, 2018 and special called meetings August 9, 13, and 16, 2018 as recorded.

On the motion of Donald Collom, seconded by Copey Grantham, and by an affirmative vote of all present to approve the claims docket 60796 - 60915.

RE: KRISTI SIZEMORE – YARD METER WATER USAGE

On August 9, 2018 the water departments meter reader, Jimmy Stevens, reported to the water clerk, Susan Echols, that the yard meter at 116 Emerson Dr. had a water hose hooked to the faucet in the meter box but that it was not listed on the handheld. Ms. Echols reviewed the account and the applications made when service was switched from 107 Briarcliff to 116 Emerson. Per the transfer Ms. Sizemore stated that she would return to put a deposit up for the yard meter. Ms. Sizemore is stating that they have indeed been using the water since they moved into the home in July 2015. She says that they have always left a hose hooked up to the meter and that our meter reader should have known that the meter was being used. Our meter reader was not present to defend the accusation. The calculation of water used from the time the previous owner had the yard meter turned off until present is approximately \$1420.00.

On the motion of Copey Grantham, seconded by Malcomb Driskill, and by an affirmative vote of Grantham and Driskill, with Aldermen Cullum, Glidewell and Sanders voting nay, to not charge the water to Ms. Sizemore because our water department did not follow procedure and lock the meter when it was turned off. As such, the motion did not carry. The City Attorney informed the board that the law states that generally if a person receives the benefit of the water service, then the city may not forgive the bill for water used. The board asked Evans to write for an attorney generals' opinion and dependent upon the answer would determine whether or not the Sizemore's would be responsible for paying the bill.
