MINUTES OF THE PROCEEDING OF THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF SALTILLO, MISSISSIPPI WHO MET IN A DULY NOTICED SPECIAL BOARD MEETING HELD ON MONDAY, AUGUST 27, 2018 AT THE CITY HALL BOARD ROOM AT 6:00 PM

Be it remembered that the Mayor and Board of Aldermen of the City of Saltillo, Mississippi met in a duly noticed special board meeting held on Monday, August 27, 2018 at the City Hall Board Room at 6:00 p.m. and the following officials were present to wit:

RE: 2018-2019 FY PROPOSED BUDGET WORKSHOP

The Mayor and Board of Aldermen met with the Water, Sewer and Street departments to go over the 2018-2019 FY Proposed Budget. The Waste Water Supervisor Ryan Flippen presented a budget that include dividing Tommy Hood's salary between street, water, and waste water since he supervises all three departments. Mike Jackson, Michael Phillips and Jimmy Stevens salaries were divided between water and sewer. After much discussion over what the rates in both the sewer and water departments needed to be the board instructed the clerk to revisit the general fund budget. She was instructed to remove the cost of living increase for the board, city attorney and city judge. She was also instructed to cut the main street donation from the city to \$5250. The board then asked the Flippen which budget that had been presented to date best met the needs of the sewer and water departments and he said the first one presented. He was told to go back to that budget which left all employees paid from the departments they are being paid from currently. The proposed water bills at this time to remain on ground water were proposed at \$17 per 2000 gallons and \$5 per 1000 on overage. The board will meet again at a later date.
