MINUTES OF THE PROCEEDING OF THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF SALTILLO, MISSISSIPPI WHO MET IN A DULY NOTICED SPECIAL BOARD MEETING HELD ON TUESDAY, AUGUST 28, 2018 AT THE CITY HALL BOARD ROOM AT 6:00 PM

Be it remembered that the Mayor and Board of Aldermen of the City of Saltillo, Mississippi met in a duly noticed special board meeting held on Tuesday, August 28, 2018 at the City Hall Board Room at 6:00 p.m. and the following officials were present to wit:

Thereupon the Mayor declared a legal quorum present and the meeting was opened for the following business:

RE: 2018-2019 FY PROPOSED BUDGET WORKSHOP

The Mayor and Board of Aldermen met with departments (present were Mark Nowell, Lindsey Hines, Brian Grissom, Ryan Flippen, and Michael Phillips) to go over the 2018-2019 FY Proposed Budget. The city clerk proposed to the board a budget for the general fund, fire, park & rec, main street and court. The proposed budget included a cost of living raise of \$610 per full time employee. This raise did not include the board, city attorney or city judge. The proposal removed the part time employee for the zoning department, proposed a \$5250 donation to the main street association and upgrade payroll software. This was a proposed balanced budget with \$400 in revenues over expenditures. Alderman Copey Grantham did not agree with the proposed cost of living raise, he believed it should include that board of aldermen. All departments present were asked to speak on behalf of their proposed budgets and hearing none the mayor moved on to discuss the water and sewer budgets. The budget that was to be proposed by Ryan Flippen and Michael Phillips was never presented because Alderman Copey Grantham immediately proposed what he believed the "correct" proposal for water rates should be. After a very intense discussion in which it was told that we had in fact met with Brandon Presley, PSC commissioner and had a meeting planned to meet with the city auditors, Franks, Franks, Wilemon and Hagood on Thursday, August 30 the board decided to wait to hear those proposals before making a decision on rates or the budget.
