RE: CHANGE ORDER - TURNER INDUSTRIAL PARK PUMP STATION

On the motion of Brian Morgan, seconded by Scottie Clark, and by an affirmative vote of all present to approve the change order from AHS in the amount of \$42,433.26. The change order will be a cost savings to the city of \$25,777.26. The original cost was \$317,277.26 and the proposed cost is \$291,500.

The original purpose of this contract, which was awarded on December 14,2021, was to replace an existing pump and wet well at Turner Industrial Park. Due to the fact that the adjoining landowner will not allow the city a construction easement, total replacement of the wet well cannot occur. However, city engineers recommend simply rebuilding the existing wet well, as opposed to full replacement, and to replace the pump. Replacement of the pump was the primary purpose of the job. This job needs to be completed as soon as possible. The board finds that this change order is necessary and incidental to the scope of the original contract; is not a new undertaking outside the scope of original contract; is commercially reasonable and in the best interest of the city; that the resulting decrease in cost is reasonable; and that the change order is not being made for the purpose of circumventing state purchasing laws.
