**MINUTES OF THE PROCEEDING OF THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF SALTILLO, MISSISSIPPI WHO MET IN A DULY NOTICED SPECIAL BOARD MEETING HELD ON MONDAY, APRIL 5, 2021 AT THE CITY HALL BOARD ROOM AT 6:00 P.M.**

Be it remembered that the Mayor and Board of Aldermen of the City of Saltillo, Mississippi met in a duly noticed special board meeting held on Monday, April 5, 2021 at the City Hall Board Room at 6:00 p.m. and the following officials were present to wit:

Mayor Rex Smith opened with the pledge of allegiance and led in a prayer.

Thereupon the Mayor declared a legal quorum present and the meeting was opened for the following business:

**RE: MIKE JACKSON – WATER DISCUSSION**

Mike Jackson came before the board to express his concerns over what he believes to be issues and needs in the water, sewer and street departments. He believes that their needs to be more cooperation between departments and administration. He said they had laid 500' of water line on South St the past week. A major leak is across the creek in front of Fred's on the Subway side. He thanked the board for the excavator. Concerned that Danny Bates is retiring June 30<sup>th</sup> and we have no one to take his place. There are sewer lines and pump stations in need of repair. We have three people mowing at a time and feels a seasonal worker would be useful.

**RE: PARK MOWER**

Alex Wilcox, Park Director, asked the board to consider purchasing a zero turn 38.5" mower for state contract price \$11610.30 from Turf Pro in Saltillo.

**RE: FIRE DEPT LAND DISCUSSION**

Chief Mark Nowell informed the board that he had been searching for land to build a new fire station. The goal is to get to a Class 5 and this would be a step in that direction.
