MINUTES OF THE PROCEEDING OF THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF SALTILLO, MISSISSIPPI WHO MET IN A DULY NOTICED SPECIAL BOARD MEETING HELD ON MONDAY, AUGUST 26, 2019 AT THE CITY HALL BOARD ROOM AT 5:30 P.M..

Be it remembered that the Mayor and Board of Aldermen of the City of Saltillo, Mississippi met in a duly noticed special board meeting held on Monday, August 26, 2019 at the City Hall Board Room at 5:30 p.m. and the following officials were present to wit:

Mayor Rex Smith opened with the pledge of allegiance and Alderman Craig Sanders led with a prayer.

Thereupon the Mayor declared no legal quorum present and the meeting was opened for the following business:

RE: DOUG WAGNER - WESTBRIER STORM DRAIN

On the motion of Craig Sanders, seconded by Terry Glidewell, and by an affirmative vote of all present to approve a quote from Dale Brock Construction for \$4255.50 to connect two sections of the city storm drain system located at and near the property of Doug Wagner on Westbrier. The board finds that these repairs are necessary in order to protect the integrity and efficiency of the city storm drain system. A construction and maintenance easement will need to be obtained from all affected property owners which shall also include permission to remove at least two (2) trees that will be necessary in order to complete the job.

RE: FINANCING FOR CHANGE OVER TO RIVER WATER

Mayor Smith informed the board that he has been in negotiations with 1st American Bank to borrow \$250,000 for the transfer over to river water. Per the bank it would cost less to deal directly with the bank. He will continue working with the bank to obtain the necessary funds to change over to river water.

RE: WATER RATES FOR THE 2019-2020 FY YEAR

On the motion of Craig Sanders, seconded by Terry Glidewell, and by an affirmative vote of Sanders, Glidewell, and Driskill with Alderman Cullum voted no to raise water rates to \$17.50 for the first 2000 gallons and \$5.80 for each 1000 gallons over. This will not go into effect until the water has been switched to river water. These rates apply to all customers: inside, within a mile, outside a mile and yard meters.

RE: 2019-2020 FY PROPOSED BUDGET

The city clerk and department heads presented to the mayor and board a balanced budget for the 2019-2020 FY Budget. This budget does include a \$1 per hour certification raise for the city clerk and a raise for Richard Gann and James Thomas in the fire dept. All other departments submitted the same budget as in the previous year. The police department has ran out of donations for bullet proof vest and is asking for \$1500 to purchase 2 vest if needed. The water departments budget is hard to calculate because there are so many unknowns and with the help of Jonathan Hagood from FFJ & H we came up with we believe to be a

feasible budget to work from. The sewer budget is being left as it was in previous year because it too will be going through major changes over the next year.

Fire Chief Mark Nowell asked the board to go into executive session to discuss a personnel matter.

On the motion of Malcomb Driskill, and affirmative vote of all present, to discuss whether a personnel matter meets the criteria of executive session.

On the motion of Craig Sanders, and seconded by Donald Cullum, and by an affirmative vote of all present to discuss a personnel issue in executive session.

Present in executive session were Mayor Rex Smith, Alderman Malcomb Driskill, Craig Sanders, Donald Cullum, and Glidewell, City Attorney Chris Evans, City Clerk Mary Parker and Fire Chief Mark Nowell. A personnel issue was discussed in executive session.

On the motion of Donald Cullum, seconded by Craig Sanders, and by an affirmative vote of all present to go out of executive session and into regular session.
