Earl Byrd came before the mayor and board to discuss the auto read meters. He informed the mayor and board that he had not got prices on Zenner meters. Mr. McNeil then spoke to the board and let them know that if we went with Zenner meters that they could not guarantee the meters. Mr. Dan DeVein from Zenner was also present and he essentially contradicted all that Mr. McNeil had to say about the Zenner meters.

The issue of a potential new city truck was discussed. The Dodge Ram 1500 is the only potential truck listed on state contract. We will look further.

The lift stations at Turner Industrial Park were discussed. They are in need of repair. Ryan and Brian are asking permission to attend class in Biloxi for their Class 4 certification.

The roof on the community center was given quotes from Reed's for \$19,744 and from Magnum for \$16,124.

Brian discussed building maintenance and M.C.A. 21-19-11 at 123 Parkridge and 108 Scotland.

The city will likely be setting water meters in all the city buildings, police, fire, city hall, city parks and Robinson building in anticipation of the switch to surface water.

Discussion of Sand Creek and board members. Richard Herring will be on the board for Saltillo.
