MINUTES OF THE PROCEEDING OF THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF SALTILLO, MISSISSIPPI WHO MET IN A SPECIAL CALLED BOARD MEETING HELD ON MONDAY, AUGUST 8, 2022 AT THE CITY HALL BOARD ROOM AT 5:30 P.M.

Be it remembered that the Mayor and Board of Aldermen of the City of Saltillo, Mississippi met in a duly noticed special called board meeting held on Monday, August 8, 2022 at the City Hall Board Room at 5:30 P.M. and the following officials were present to wit:

Mayor Copey Grantham opened with the Pledge of Allegiance to the flag of the United States of America and Alderman Scottie Clark led in prayer.

Thereupon the Mayor declared a legal quorum and the meeting open for business.

RE: BUDGET WORKSHOP

The mayor discussed the 2022-2023 Budget proposals. Jonathan Hagood with Franks, Franks, Wilemon and Hagood spoke to the board and department heads about the possibility of raising the mileage rates. With the assessed values of the city's assessed values, we could raise the mileage rate to 28.50 (1.5 mils). This would generate \$912 in property taxes for the next year.

The revenues general fund revenues (\$2,745,759) as proposed did not meet the requested expenditures (\$3,016,580). The mayor and board asked the department heads to remove all request that were above and beyond last years budget. Raises will be considered at 2% or as presented by department heads if approved by the board. Dustin Hathcock is asking to move his men to the departments they work the most in with raises for Jackson, Gray, and Chris at \$1.00; Penny, Ambrose and Donahue at \$2.00; Phillips at \$1.50. The police chief removed his request for 2 vehicles. The fire chief removed his request for 3 men but is still asking for 1 more man and he will put assistant chief to shift again. The park and rec removed another man and the carry all 500. The clerk will rework the numbers and set down with the department heads to balance the budget. We will call a meeting later to go over the numbers again.
