#### RE: WATER

On the motion of Craig Sanders, seconded by Terry Glidewell, and by an affirmative vote of all present to purchase materials needed to cap of a 6" line which runs past the elementary school and to cut and tap a 12" line which would feed Herring Hill, Treatment Plant and Fellowship road. The purchase of pipes will be through Consolidated Pipe & Supply Co. for a quoted price of \$2004.60. This cost does not include the cost of hiring a company to do the tap. The city does not have equipment to make a tap of that size.
