RE: HEALTH INSURANCE

On the motion of Scottie Clark, seconded by Craig Sanders, and by an affirmative vote of all present to approve the quote submitted by Ross and Yerger for health insurance for a plan with Blue Cross Blue Shield (\$366.67) and AmFirst Ins (\$56.25) companies for a total of \$422.92 per employee per month.
