MINUTES OF THE PROCEEDING OF THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF SALTILLO, MISSISSIPPI WHO MET IN A DULY NOTICED SPECIAL BOARD MEETING HELD ON MONDAY, DECEMBER 14, 2020 AT THE CITY HALL BOARD ROOM AT 6:00 P.M.

Be it remembered that the Mayor and Board of Aldermen of the City of Saltillo, Mississippi met in a duly noticed special board meeting held on Monday, December 14, 2020 at the City Hall Board Room at 12:00 p.m. and the following officials were present to wit:

Mayor Rex Smith opened with the pledge of allegiance and Alderman Scottie Clark led in prayer.

Thereupon the Mayor declared a legal quorum present and the meeting was opened for the following business:

RE: HEALTH INSURANCE

Due to a misunderstanding of the quote for health insurance by Affordable Employee Benefits the board revisited the information submitted.

On the motion of Scottie Clark, seconded by Craig Sanders, and by an affirmative vote of all present to once again approve the quote submitted by Ross and Yerger for health insurance for a plan with Blue Cross Blue Shield (\$366.67) and AmFirst Ins (\$56.25) companies for a total of \$422.92 per employee per month. This quote was considered the lowest and best quote, under the circumstances, pursuant to state purchasing laws. The board finds that Ross and Yerger has carried the city's health insurance plan under the same base policy for many years in the past and there is a possibility that the base policy may not be exactly the same if changed to a new agent/broker and that such change would also require additional work and less familiarity on the part of the city clerk. The quote from Affordable Employee Benefits should have been given as \$412.53, not the \$441.67 as believed at the last meeting.
