On the motion of Malcolm Driskill, seconded by Craig Sanders, and by an affirmative vote of all present to authorize ESI to begin the process of advertising for bids for materials for water line to serve Cross Creek subdivision.

On the motion of Malcolm Driskill, seconded by Craig Sanders, and by an affirmative vote of all present to authorize ESI to begin the engineering and developing a plan to install a 12" line along McComb to Old 45 to replace a 4" line.

On the motion of Malcom Driskill, seconded by Copey Grantham, and by an affirmative vote of Driskill and Grantham with nay votes from Donald Cullum, Terry Glidewell and Craig Sanders to switch the west side of town back to surface water with Northeast MS Regional Water District with the conditions it would be at maximum cost of \$35,000.00 and with no long term contract. The said motion did not pass (2-3), with those voting nay having stated that they needed more information before passage.
