**MINUTES OF THE PROCEEDING OF THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF SALTILLO, MISSISSIPPI WHO MET IN A DULY NOTICED SPECIAL BOARD MEETING HELD ON FRIDAY, FEBRUARY 22, 2019 AT THE CITY HALL BOARD ROOM AT 12:00 PM**

Be it remembered that the Mayor and Board of Aldermen of the City of Saltillo, Mississippi met in a duly noticed special board meeting held on Friday, February 22, 2018 at the City Hall Board Room at 12:00 p.m. and the following officials were present to wit:

Present: 1<sup>st</sup> District Supervisor Phil Morgan; State Senator Chad McMahan; PSC Southern District Sam Briton; Chief Police Grant Bailey; Fire Chief Mark Nowell; Building and Zoning Administrator Brian Grissom.

Mayor Smith led with the pledge of allegiance and Alderman Craig Sanderled with a prayer. Thereupon the Mayor declared a legal quorum present and the meeting was opened for the following business:

**RE: PROCLMATION OF LOCAL EMERGENCY AND ENACTMENT OF GENERAL CURFEW**

On the motion of Craig Sanders, seconded by Copey Grantham, and by an affirmative vote of all present Pursuant to and in accordance with Mississippi Code Annotated Section 33-15-17 (1972, as amended), the Mayor and Board of Aldermen of the City of Saltillo, Mississippi hereby declare a state of local emergency as of 12:00 PM on Thursday, February 21, 2019, related to the recent inclement weather and resulting potentially dangerous roadway conditions within the municipal boundaries of the city. The Saltillo Police Department and Saltillo Fire Department are hereby authorized to take any and all reasonable and necessary actions to protect the public interest. The Saltillo Board of Aldermen will review this matter at its next regularly scheduled meeting on Tuesday, March 5, 2019, if not before, as may be necessary.

As such, in order to further preserve public order and safety, travel is hereby restricted as to all individuals, other than residents and their immediate family members and emergency personnel, within the Willow Creek Subdivision from 3:00 PM on Friday, February 22, 2019 until 3:00 PM on Saturday, February 23, 2019. This order will be subject to review and extension by the Mayor, as may be necessary.

**RE: ENGINEERING AGREEMENT FOR SERVICES**

On the motion of Donald Cullum, seconded by Craig Sanders, and by an affirmative vote of Aldermen Cullum, Driskill, Glidewell, and Sanders with Alderman Grantham voting nay to give Mayor Smith permission to sign the agreement for engineering services, including the applicable compensation and C schedule, between the City and Engineering Solutions, Inc. The selection was made in accordance with state and federal law after a request for qualifications was duly published and advertised and after the three responding candidates were properly graded and rated by the members of the board of aldermen.
