**RE: BANK BIDS**

On the motion of Terry Glidewell, and seconded by Donald Cullum, and by an affirmative vote of all present to approve a duly advertised bid submitted by Renasant Bank to serve as the depository bank for the city for a period of time from February , 28, 2020 until January 31, 2022. Renasant Bank is proposing no fees for service charge, no minimum daily balance, no fees for stop payment, overdraft protection, and safe deposit box and interest rate of 1.31% on all public fund deposits. BancorpSouth also submitted a bid parallel to Rensant except the interest rate proposed was 1.3%.


