Pursuant to and in accordance with Mississippi Code Annotated Section 33-15-17 (1972, as amended), the Mayor of the City of Saltillo, Mississippi hereby declares a state of local emergency related to the recent inclement weather and resulting dangerous roadway conditions within the municipal boundaries of the city.

As such, in order to preserve public order and safety, a general curfew is hereby imposed as to all individuals, other than emergency personnel, from 8:00 PM on Tuesday, January 16, 2018 until 6:00 AM on Wednesday, January 17, 2018, to be enforced by the Saltillo Police Department and/or any other law enforcement agency or personnel.
