### **RE: DEPOSITORY BIDS**

On the motion of Craig Sanders, seconded by Malcomb Driskill, and by an affirmative vote of all present to accept the bid from Renasant Bank to serve as the depository bank for the City of Saltillo for a two (2) year period. Bids were properly solicited and noticed and the Renasant bid was chosen as being the lowest and best bid for the City pursuant to Mississippi Code Section 27-105-353. Further, as stated above, these bank bids will be accepted for two (2) years as provided under Mississippi Code Section 27-105-363. Bancorp South also submitted a bid.

Renasant's proposal includes a special interest rate along with additional services that Renasant Bank can provide the City. Renasant Bank will not charge a service fee on the public fund accounts in the name of the City. Fees will not be charged for returned deposit items, overdrafts or stop payments, safe deposit box, and no minimum daily balance. Renasant Bank will issue night depository bags and keys free of charge. ACH Origination services including direct deposit of payroll, automatic draft payments, accounts payable disbursements and any other reimbursements can be offered at no charge.
