On the motion of Copey Grantham, seconded by Craig Samders, and by an affirmative vote of all present to approve the agenda for the Special Called Meeting July 31, 2018.

RE: MEG'S LANE EMERGENCY REPAIR

On the motion of Copey Grantham, seconded by Malcomb Driskill, and by an affirmative vote of all present to declare the sink hole and collapsed storm drain at Meg's Lane to be an emergency and to enter an emergency contract with Dale Brock Construction for the repair of same at a maximum amount of \$15,000.00. An exact estimate for repairs cannot be determined at this time until the sink hole and collapsed drainage pipe are excavated further, which will then worsen the situation which will then need to be addressed immediately. This situation presents a clear and present danger to the community of potential irreparable harm and the failure to repair immediately will serve as a detriment to the city as a whole, thus negating the necessity for competitive quotes under emergency state purchasing laws.

RE: ORDER ON THE MINUTES - WATER FUND

On the motion of Terry Glidewell, seconded by Copey Grantham, and by an affirmative vote of all present to transfer money from account 400-650-990 (Water Rehab) to 400-650-604 (Engineering) to pay invoice to ESI for \$31,807.50. This is part of project P18-155 Old 45 Water Line Upgrade.

RE: AQUAKLEAR TREATMENT PLANT

On the motion of Craig Sanders, seconded by Copey Grantham, and by an affirmative vote of all present to approve the quote from GreenPro, LLC to install (2) 500 gallon per day Aquaklear Treatment Plants with overload discharge near 173 Scotland Dr and 181 Scotland Dr. A quote from Ingram Electric and Plumbing (\$7,700) was also considered. These new treatment plants will be used to replace existing city pump stations at these locations which are outdated and in need of replacement. These treatments plants are necessary to maintain the overall integrity and efficiency of the city sewage treatment system.

RE: WILLIE TAYLOR HIGH BILL
