PLEASE TAKE NOTICE that pursuant to and in accordance with Section 23-15-857 of the Mississippi Code Annotated (1972, as amended) and other relevant portions of state law, the

Saltillo Board of Alderman has called a special election for the open position of alderman to take place between the hours of 7:00 AM and 7:00 PM on Thursday, March 5, 2020 at the Saltillo Community Center. If a candidate does not receive a majority of the votes cast, then a run-off will take place between the top two candidates during the same hours and at the same location on March 26, 2020.

The qualifying deadline for potential candidates is 5:00 PM on Friday, February 14, 2020. Please see the Saltillo City Clerk at Saltillo City Hall in order to obtain the necessary qualifying paperwork or to request additional information.

Absentee ballots will be available beginning on February 17, 2020 during the hours of 8:00 AM until 5:00 PM and on Saturday February 22 and 29, 2020 between the hours of 8:00 AM and 12:00 PM. All such absentee ballots must be completed and returned to the Saltillo City Clerk by no later than 5:00 PM on March 3, 2020. If a run-off is necessary, then absentee ballots for the said run-off shall be available beginning on Monday, March 9, 2020 between the hours of 8:00 AM until 5:00 PM and on Saturday March 14 and 21, 2020 between the hours of 8:00 AM and 12:00 PM. All run-off absentee ballots must be completed and returned to the Saltillo City Clerk by no later than 5:00 PM on March 24, 2020.

Pursuant to newly passed Senate Bill 2030, in addition to the other necessary standard qualifications, each potential candidate must certify in writing that they have been a resident citizen of the City of Saltillo since at least March 5, 2018 in order to run for this position.

This Notice shall be published on February 2, 9 and 16, 2020 and shall also be posted in accordance with state law.
