**RE: METERS AT TRAILER PARK**

On the motion of Craig Sanders, seconded by Donald Cullum, and by an affirmative vote of all present to charge Bobby Williams two (2) meter deposits for meters which serve all of his trailers at the location at Faye, Gary, and Ricky drive. Consolidating these meters, at the full agreement of the owner, will greatly assist the city in water service billing and collection for these locations.
