**MINUTES OF THE PROCEEDING OF THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF SALTILLO, MISSISSIPPI WHO MET IN A DULY NOTICED SPECIAL BOARD MEETING HELD ON TUESDAY, JULY 21, 2020 AT THE CITY HALL BOARD ROOM AT 11:30 A.M.**

Be it remembered that the Mayor and Board of Aldermen of the City of Saltillo, Mississippi met in a duly noticed special board meeting held on Tuesday, July 21, 2020 at the City Hall Board Room at 11:30 a.m. and the following officials were present to wit:

The Mayor opened with the pledge of allegiance and Alderman Scottie Clark led with a prayer.

Thereupon the Mayor declared a legal quorum present and the meeting was opened for the following business:

**RE: PERSONNEL**

On the motion of Donald Cullum, seconded by Copey Grantham, and by an affirmative vote of all present to hire Charles Alexander Wilcox (Alex) as the Park & Rec Director with a salary of Fifty Thousand (\$50,000.00) per year, plus all benefits due a full-time city employee. The board also gives Mr. Wilcox permission to work a maximum of thirty-five (35) additional hours on weekends when private ball tournaments are being held in Saltillo city facilities. He will be compensated for these events by the tournament itself or through a privately incorporated entity for that purpose. These extra duties will be performed once his full-time duties for the city have been completed. The board has agreed that it will conduct a review in approximately six (6) months wherein his salary will be analyzed and adjusted, if necessary, commensurate with the perceived level of success of the parks and recreation department under his leadership during the interim. The board requests that a five year (5) comprehensive plan of his vision and recommendations of the parks and recreation department going forward be presented at the review.
