**RE: EMERGENCY SEWER LINE REPAIR - SYNTRON**

On the motion of Craig Sanders, seconded by Donald Culum, and by an affirmative vote of all present to that the board finds that the broken sewer line in the creek at Syntron to be an emergency and needs to be repaired immediately due to raw sewage being dumped into the creek. This is in addition to the west side of the line that was previously voted upon due to raw sewage dumping into the creek.

On the motion of Copey Grantham, seconded by Donald Cullum, and by an affirmative vote of all present to engage AHS Construction to repair the sewer line break for a quote of Thirty two thousand dollars. A quote was also submitted by Eubank construction for Seventy five thousand dollars .
