Be it remembered that the Mayor and Board of Aldermen of the City of Saltillo, Mississippi met in a duly noticed special board meeting held on Monday, June 21, 2021 at the City Hall Board Room at 5:30 p.m. and the following officials were present to wit:

On the motion of Donald Cullum, seconded by Copey Grantham, and by an affirmative vote of all present to hire Daniel McKinney as Police Chief for \$53,000.00 annually, with all benefits due a full-time employee, to be effective Monday, June 28<sup>th</sup>, 2021.

On the motion of Scottie Clark, seconded by Craig Sanders, and by an affirmative vote of all present to hire Jeff Brown as Assistant Police Chief for \$48,000.00 annually, with all benefits due a full-time employee, to be effective Friday, July 2, 2021.
