On the motion of Craig Sanders, seconded by Scottie Clark, and by an affirmative vote of all present to borrow \$90,000.00 from the sewer reserves, to be placed back into the reserves when the city receives its \$90,000.00 grant as approved by the State Fire Marshal's office per the RFTAAP program. The \$90,000 will be placed into account 003-000-380. The city has been pre-approved for this grant and it is anticipated that the funds will be received within the next few months.

Sprotsplex previously approved in the May 17, 2022 board meeting. This payment was approved and recommended by the duly appointed project architect.

RE: PURCHASE OF PLAYGROUND EQUIPMENT THROUGH THE BCBS GRANT

Moonshot Recreation is the only authorized dealer for this equipment in the state of Mississippi. The city received documentation from the vendor indicating that this is a single-source item and therefore additional quotes or bids could not be obtained and are not required under state purchasing laws. This purchase is made with funds from the BCBS Healthy Hero grant and BCBS recommended this exact "exercise-style" playground equipment in awarding the grant.

RE: TREE REMOVAL QUOTES

On the motion of Brian Morgan, seconded by Craig Sanders, and by an affirmative vote of all present to accept the quote from Bill Russell to cut down two (2) trees on Old Saltillo Road for \$2000.00. American Tree Service also submitted a quote of \$3,600.00. These trees are on city property and need to be removed in order to prevent the trees from possibly falling onto private property.

On the motion of Craig Sanders, seconded by Terry Glidewell, and by affirmative vote of all present to approve the change order of \$24,775.50 to finish the sidewalk project on Mobile and Second Street. This project was previously approved and awarded by the board after advertising for competitive quotes under state purchasing laws. During the construction phase of this project, it was determined that various design changes to the project would be necessary related to stormwater drainage. The board finds that this change order deals with unforeseen conditions that arose during the original construction phase; that this change order is being made in a commercially reasonable manner and is necessary in order to complete the project; and that the change order is not being made in order to circumvent state purchasing laws.
