MINUTES OF THE PROCEEDING OF THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF SALTILLO, MISSISSIPPI WHO MET IN A DULY NOTICED SPECIAL BOARD MEETING HELD ON THURSDAY, JUNE 20, 2019 AT THE CITY HALL BOARD ROOM AT 12:00 PM

Be it remembered that the Mayor and Board of Aldermen of the City of Saltillo, Mississippi met in a duly noticed special board meeting held on Thursday, June 20, 2019 at the City Hall Board Room at 12:00 p.m. and the following officials were present to wit:

Mayor Smith led with the pledge of allegiance and Terry Glidewell led with a prayer.

Thereupon the Mayor declared a legal quorum present and the meeting was opened for the following business:

RE: REGIONAL WASTE WATER PROJECT

Jon Milstead with CDF came before the board to give an update on the Sande Creek Sewer Project. The purpose of the proposed project was to provide a service to Baldwyn and Guntown and to upgrade the system that Saltillo already had in place. A public hearing will be held on Monday, July 1, 2019 at 9:30 a.m. at the Lee County Board of Supervisor's office.

RE: POLICE DEPT

On the motion of Donald Cullum, seconded by Craig Sanders, and by an affirmative vote of all present to grant permission to Brent Green to drop from a full time police officer to a part time officer. This will be effective June 26th, 2019 and he will no longer be eligible for full time benefits.

Alderman Grantham arrived at the meeting at 12:23 p.m.

On the motion of Donald Cullum, seconded by Craig Sanders, and by an affirmative vote of all present to hire Jonathan Boyd with the understanding that he will be on 90 day probation. He will be paid \$14.00 per hour and will receive all benefits due to a full time employee.

On the motion of Craig Sanders, seconded by Donald Cullum, and by an affirmative vote of all present to hire Ricky Culver as a full time police officer with the understanding he will need to attend the police academy in January. He will begin at a pay rate of \$13.50 per hour and when the academy has been completed he will be given a raise to \$14.00 per hour.

On the motion of Malcomb, seconded by Donald Cullum, and by an affirmative vote of Sanders, Cullum, Driskill, and Grantham, with Glidewell voting nay to hire Chris Gilland at \$14.00 per hour and all benefits due a full time officer. He will be on 90 day probation.

On the motion of Malcomb Driskill, seconded by Copey Grantham, and by an affirmative vote of all present to raise Dylan Whitt's hourly rate to \$14.50 per hour effective immediately (6/20/2019).
