MINUTES OF THE PROCEEDING OF THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF SALTILLO, MISSISSIPPI WHO MET IN A DULY NOTICED SPECIAL BOARD MEETING HELD ON MONDAY, MARCH 26, 2018 AT THE CITY HALL BOARD ROOM AT 5:45 P.M.

Be it remembered that the Mayor and Board of Aldermen of the City of Saltillo, Mississippi met in a duly noticed special board meeting held on Monday, March 26 2018 at the City Hall Board Room at 5:45 p.m. and the following officials were present to wit:

The Mayor opened with the pledge of allegiance and led with a prayer.

Thereupon the Mayor declared a legal quorum present and the meeting was opened for the following business:

RE: APPROVE AGENDA ITEMS

On the motion of Donald Cullum, seconded by Craig Sanders, and by an affirmative vote of all present to approve the agenda for the Special Called Meeting March 26, 2018

Ordered this the 26th day of March, 2018

RE: SEWER TO CROSS CREEK SUBDIVISION

On the motion of Craig Sanders, seconded by Donald Cullum, and by an affirmative vote of all present to approve the City purchasing the materials for a sewer pressure line to run from the city sewer system to the proposed Cross Creek Subdivision. In exchange for this purchase, the developer, Mitchell Scruggs, has agreed to hire a licensed and bonded contractor to construct and install the said sewer line. The construction and installation by the said contractor shall meet city engineering specifications and shall be in accordance with all state and federal regulatory requirements/approvals and property easements, if necessary. The developer must also obtain a performance bond or letter of credit to protect the investment of the City at 125% in the purchase of the materials. A rough estimate of \$60,000.00 is anticipated for the cost of the materials and the City shall begin the bid process to purchase the pipe and materials as soon as possible. This arrangement is essentially the same as the City previously agreed concerning water service to this proposed subdivision, and the willingness of the City to invest in these items is based upon the reasonable expectation that the City will be allowed to provide water and sewer services to the subdivision.

On the motion of Copey Grantham, seconded by Craig Sanders, and by an affirmative vote of all present to set the water connection fee at Three Hundred Dollars (\$300.00) for Cross Creek Subdivision due to the fact that the developer, Mitchell Scruggs, will provide and install all water curb stops pursuant to city specifications. The sewer connection fee will remain at \$500.00.
