RE: JIM & BETTY MILLER – WATER ISSUES

Mrs. Betty Miller came before the board to speak for herself and her husband Jim Miller to complain their water since it was changed over in September, 2017 from river to well water. They are still experiencing dingy water, a smell to the water and an unpleasant taste. They are spending an average of \$5 per case for bottled water and \$50 for filters for their ice machine. Jason Herring also echoed the same complaints as the Millers. Public Service Commissioner Brandon Presley informed the board he was there because of complaints his office was receiving. The PSC sets the rates for those persons outside the 1(one) mile radius. He informed the board he was willing to send representatives from his office to speak with the board on May 15th, 2018 at 10:30 a.m. concerning options the board may have to improve the water conditions and discuss whether his office would be willing to approve rates increases for the area outside the city limits to fund the changes. Marsha Flynn of CR 445 also spoke and told the board that she believes the condition of the water is keeping families from moving into the area.

On the motion of Terry Glidewell, seconded by Malcomb Driskill, and by an affirmative vote of all present to respond to the letter from Ms. Jewell Webb that the Saltillo Board of Aldermen has determined that the following items being kept at the Dr. R.B.Robison Resource Center are suitable for release to her, by or before May 16, 2018 (numbered according to her list of April 20, 2018): (1) used desk; (2) file cabinets, desk and chair; (4) heavy duty rolling table; (6) bookcases; (7) children's small round table; (8) children's furniture, books and book cases and off-set table; (9) office and school supplies; (10) remainder of four boxes of pens (copy paper has already been consumed); (11) metal tables; (13) weaving loom; (14) first-aid kit; (15) shelving; (16) long table in kitchen; (17) office chairs, bar chairs, rolling chairs (only 8 total to be removed) and burgundy office chairs; (18) open/closed sign for door; (19) three-way table, stool and bench; (20) table with drawers; (22) large round table; (23) small podiums; (24) books and school supplies in supply room; and (25) black roll desk and 10 blue children's chairs. By letter of April 20, 2018, Ms. Webb requested the release of the above items of property, as well as others, which she indicated belonged to her and were simply kept for use by the city in the resource center building. The city conducted an investigation and determined that some of the items requested in the letter had either been officially accepted by the Board as a city donation, were

otherwise placed on official city inventory, or city manpower had been used in the procurement of same. As such, these particular items were determined to be the property of the city and will be kept by the city for official use. The remaining items listed above were determined not to be the property of the city and were therefore suitable for release to Ms. Webb as per her assertion that the said remaining items were her personal property.

As a side note, the Mayor, as essentially the chief executive officer of the city, can write up a disciplinary report on any department head or employee.

On the motion of Terry Glidewell, seconded by Donald Cullum, and by an affirmative vote of three (3) aldermen Donald Cullum, Terry Glidewell and Craig Sanders with Aldermen Malcomb Driskill and Copey Grantham voting nay, to remove a recent disciplinary write-up, prepared by a non-department head, out of the personnel file of an employee of the police department.
