MINUTES OF THE PROCEEDING OF THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF SALTILLO, MISSISSIPPI WHO MET IN A DULY NOTICED SPECIAL BOARD MEETING HELD ON MONDAY, MAY 15, 2018 AT THE CITY HALL BOARD ROOM AT 1:30 P.M.

Mayor Rex Smith opened with the pledge of allegiance and led in prayer.

Thereupon the Mayor declared a legal quorum present and the meeting was opened for the following business:

RE: WORKSHOP – PSC ON WATER

Present from the PSC were Commissioner Brandon Presley, Chris Hutcheson, James Richard and Mike McCool. They came to hear from the Mayor and Board concerning the water issue on the area one (1) mile outside. He asked what the city was doing to improve the situation. The Mayor explained that we were “hard” flushing the lines at least once per month and that seemed to be improving the water. Also, the city leaders along with the public works director and all engineers involved believe that the line size is a big concern and therefore will be install a 12” line along Old 45. Mr. Presley gave the mayor and board a list of things he would like to have answered over the next few months. First he would like to see a report of the water condition after each flush and then every two weeks a report on the water condition. He would then like to know how many complaints we are receiving from households in the PSC jurisdiction. He asked the clerk for a list of all persons and their addresses so that the commission may send them a letter to let them know that they are working with the city to improve the water in their area.
