# MINUTES OF THE PROCEEDING OF THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF SALTILLO, MISSISSIPPI WHO MET IN A DULY NOTICED SPECIAL BOARD MEETING HELD ON MONDAY, MAY 7, 2018 AT THE CITY HALL BOARD ROOM AT 5:30 P.M.

Be it remembered that the Mayor and Board of Aldermen of the City of Saltillo, Mississippi met in a duly noticed special board meeting held on Monday, May 7, 2018 at the City Hall Board Room at 5:30 p.m. and the following officials were present to wit:

Mayor Rex Smith opened with the pledge of allegiance and Alder led in prayer.

Thereupon the Mayor declared a legal quorum present and the meeting was opened for the following business:

Engineers for ESI and Cook Coggin were present.

#### RE: WORKSHOP - WATER

City Engineer Mike Faulkner (ESI) presented 3 analysis scenarios for the board to consider.

- 1) Stay on groundwater, fix known hydraulic problem areas: Cost increase per customer/ month \$4.41
  - A. Old 45 upgrade.
  - B. 8" upgrade along Eclatubba Road
  - C. 12" upgrade on 731/2446
- II) Convert to surface water, still need to fix hydraulic issues: Cost increase per customer/month \$8.21
  - A. Cost for reconnect at Turner Park need both connections (Cook Coggin Engineers Options 2a & 3b)
  - B. Item I tasks
  - C. Purchase cost of water from NEMRWS
- III) Stay on groundwater, fix hydraulics, add filter: Cost increase per customer/month \$9.43
  - A. Item 1 tasks
  - B. 3-10' greensand filter systems, installed with sitework @ \$200k/ each
    - 2- dual 10' greensand filter systems, installed w/sitework @ \$350 k/each
  - C. Operator upgrades to Class B

After a few minutes of discussion Malcomb Driskill left the meeting.

The Board asked ESI to look at the possibility of the increase only being \$5 per month per customer and to come back with those numbers and what upgrades would need to take place.
