MINUTES OF THE PROCEEDING OF THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF SALTILLO, MISSISSIPPI WHO MET IN A DULY NOTICED SPECIAL BOARD MEETING HELD ON MONDAY, MARCH 1, 2021 AT THE CITY HALL BOARD ROOM AT 6:00 P.M.

Be it remembered that the Mayor and Board of Aldermen of the City of Saltillo, Mississippi met in a duly noticed special board meeting held on Monday, March 1, 2021 at the City Hall Board Room at 6:00 p.m. and the following officials were present to wit:

The Mayor opened with the pledge of allegiance and Terry Glidewell led with a prayer.

Thereupon the Mayor declared a legal quorum present and the meeting was opened for the following business:

RE: GOVERNMENT CONSULTANTS, INC

On the motion of Copey Grantham, seconded by Craig Sanders, and by an affirmative vote of all present to proceed with considering proposed refinancing 91-10 and 91-12 USDA Loans with Duncan Williams at a projected savings of \$314,887 over a 20 year period.

Brian Grissom explained to the board that Bobby Williams was wanting to place a single storage building on property behind the old bank on Second Street. This would require a request for a nonconforming use and a public hearing.

RE: HIRE PART-TIME CODE ENFORCER

On the motion of Scottie Clark, seconded by Donald Cullum, and by an affirmative vote of all present to hire Danny Smith (current animal control officer) as a part-time code enforcer. He will be limited to 2 days (16 hours) per week at \$12.00 per hour. Effective immediately.

RE: DOWNTOWN CONCERT – MARCH 13, 2021

On the motion of Scottie Clark, seconded by Copey Grantham, and by an affirmative vote of all present to allow Old Town Restaurant and Saltillo Main Street Association to sponsor a concert to be held Saturday, March 13, 2021 from 7:30 to 10:00 p.m. pursuant to the following conditions: Mobile Street must be gated or cordoned off; all beer sales must be handled in accordance

with state law; participants must stay in the street and not on the sidewalk; porta johns must be provided; three off-duty officers will be hired and paid by the restaurant and Main Street Association; Main Street Association to provide a copy of their liability insurance; Old Town and owners will sign indemnification agreement for city; Old Town and Main Street Association must clean up immediately after event; no one under 21 allowed to drink alcohol.
