RE: COVID-19 VIRUS POLICY AND PROCEDURES IN CASE OF EMERGENCY

On the motion of Craig Sanders, seconded by Donald Cullum, and by an affirmative vote of all present to allow the maintenance department work in two (2) groups taking off five (5) days at a time but that they would be on call to be called to work in case they are needed and they will be paid as normal. The two clerks in the water dept. will be sent home for fifteen (15) days and will return on April 6th, 2020 with pay but may be subject to be called out in case of an emergency. The city clerk will be in the front office to absentee vote and to take care of business up front. These arrangements are hereby made as the result of and in conjunction with the local, state and federal state of emergency previously declared.
