MINUTES OF THE PROCEEDING OF THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF SALTILLO, MISSISSIPPI WHO MET IN A DULY NOTICED SPECIAL BOARD MEETING HELD ON THURSDAY, MARCH 25, 2021 AT THE CITY HALL BOARD ROOM AT 5:30 P.M.

Be it remembered that the Mayor and Board of Aldermen of the City of Saltillo, Mississippi met in a duly noticed special board meeting held on Thursday, March 25, 2021 at the City Hall Board Room at 5:30 p.m. and the following officials were present to wit:

Mayor Rex Smith opened with the pledge of allegiance and Alderman Craig Sanders led in a prayer.

Thereupon the Mayor declared a legal quorum present and the meeting was opened for the following business:

RE: "BROWN BAG" EXCEPTION REQUEST

On the motion of Donald Cullum, seconded by Craig Sanders, and by an affirmative vote of all present to approve a special exception for Lee and Stephanie West, doing business as A6 Restaurant, to allow "brown bagging" of wine or liquor to take place upon the premises on a trial basis until July 31 2021, with the following conditions:

- 1. Wine or liquor cannot be kept or stored on the premises at any time.
- 2. The owners or employees cannot handle or help to serve any of the wine or liquor.
- 3. The "brown bagging" shall be allowed to take place on Thursday through Saturday from 5:00 PM until 11:00 PM.
- 4. The premises will need to provide adequate security and will need to verify that no one under 21 is allowed to drink alcohol of any type.
- 5. The premises will need to verify that no one overserves themselves or obviously consumes too much alcohol, within reason. This will be a subjective, common-sense standard.
- 6. The owners will provide sealable bags so that those leaving the premises with unconsumed containers of alcohol can place said containers in such a bag prior to leaving. The owners will notify the patrons of this requirement.
- 7. The premises will need to have adequate liability insurance and will need to agree to indemnify the city from any claims or liability.
- 8. The premises will need to advise patrons that, upon leaving with unconsumed wine or liquor, they will need to keep the bag and bottle sealed and stored outside the passenger compartment of their vehicle, such as in the trunk of a car, etc.

It is noted that a duly noticed public hearing was conducted as to this specific issue on or about March 16, 2021 at which time no person or entity objected to the special exception request.

RE: SONYA GRIMES - HIGH WATER BILL

On the motion of Copey Grantham, seconded by Craig Sanders, and by an affirmative vote of all present to remove all late fees from the amount due on Sonya Grimes water bill which totals \$64.97 and to allow her to make three payments of \$84.17 on the balance of the \$252.51 plus the monthly bill due. These arrangements are being made due to the fact that the customer had a leak on her end of the service and therefore did not receive the benefit of all services billed.
