Be it remembered that the Mayor and Board of Aldermen of the City of Saltillo, Mississippi met in a duly noticed special called board meeting held on Tuesday, May 17, 2022 at the City Hall Board Room at 6:30 P.M. and the following officials were present to wit:

Thereupon the Mayor declared a legal quorum and the meeting open for business.

RE: BUDGET WORKSHOP

The Mayor discussed the 2022-2023 Budget proposals. Jonathan Hagood with Franks, Franks, Wilemon and Hagood spoke to the board and department heads how to plan a budget around the tax mileage. The mileage is set according to the needs of the expenditures. The board may raise mileage rate up to 10% of current rate.

Each department then spoke about their needs for the upcoming year. All departments are hoping to keep the same budget as was proposed for the 2021-2022 budget before amendments had been made. The public works is proposing realigning their employees to better suite the work being done. This would include moving Chris Nicholson to street, Mike Gray to water and Corey Donahue to sewer. He is wanting a \$2 per hour raise for Donahue and Ambrose. Police chief Daniel McKinney is hoping to put a computer system into the police cars for reports and tickets. Also, would like to add another car this year. The fire department is stating that if the larger manufacturing comes into the city that they will need a ladder truck, 3 additional men and a centrally located station. Park and Rec is wanting to add another employee and to continue with improvements to the parks and buildings. Brian Grissom is requesting an employee to do the code enforcement. The admin budget is being requested to stay as proposed for the 2021-2022 budget.


