Chief McKinney reported the department had written 65 reports; 9 felonies; 11 arrests; 16 DUI reports; 8 vehicle accidents; and 140 citations during the prior month.

RE: FIRE DEPARTMENT - MONTHLY UPDATE

Chief Mark Nowell gave a report of 4 fire calls; 41 EMS calls; 1 haz-mat call; and 7 service calls. He had 140 calls for the year. They have finished painting the front of the station, waiting on signage and have received a flag pole donation from Woodmen Life. The new truck should be here around the 6th of June. Nowell, assistant chief Jenkins and Gann will be traveling to Florida to inspect the truck. Engine 1 has been sold to a votech school in Texas as part of the trade-in which was previously approved by the board. He has completed the yearly hose test and hydrant maintenance. The volunteers will be holding a yard sale May 13 and 14 to purchase an animated Sparky for public-relations use. Chief Nowell provided a list of department employees which include 5 full-times, 11 part-time as needed and 18 volunteers.

RE: PARK & REC MONTHLY UPDATE

Park Director Alex Wilcox informed the board that registrations were up from last year. He had received a grant for \$4,500.00 to resurface the tennis courts. He had 27 team sponsors. The pre-bid meeting for the possible turf field project will take place at WK Sportsplex on Thursday, May 5th and the opening of the bids will be May 15, 2022.

RE: BIDS FOR BATHROOMS AND DUGOUTS

Bids were received from Dale Brock Construction to repair the park bathrooms for \$31,100.00 or to rebuild for \$62,200.00 and a bid was also received from Stewart Environmental to repair for \$49,985.00 or to rebuild for \$96,650.

Bids on the dugouts were received from Dale Brock Construction for \$56,000.00 and Stewart Environmental for \$44,950.00.

No action was taken, but the board asked Wilcox to get proposed plans and specs for bathrooms, concession stand and dugouts and to come back in order for the board to possibly advertise for bids for the work to be done since it appears that the work necessary to fully correct the issues would cost in excess of \$50,000.00.

Added a pump station at the Sportsplex and set a line for Willow Creek pump station. The water department finished their yearly inspection and received a 5 out of 5. Doing lead and copper samples. Made taps for the Town Creek Shopping Center and fixed 2 major water leaks. Did a total of 150 locates that had been called in.
