On the motion of Scottie Clark, seconded by Donald Cullum, and by an affirmative vote of all present to enter into an inter-governmental purchase from Lee County to pave streets Water and Knight (\$44,352.00) Westwood, Stage, Connie, and West brier (\$59,200.00). Oak and Bostic. The modernization funds will be used. This is an intragovernmental purchase from Lee County that takes advantage of the county's bulk materials discount and, therefore, quotes or bids are not necessary under state purchasing laws. The streets to be paved with asphalt are Water, Westwood, Saddle Creek, Connie, Westbrier and Knight for \$44,352. Lee County has been asked to pave Oak Street and Bostic Ave. at their cost.

RE: BOBBY WILLIAMS STORAGE BUILDING REQUEST/ NUISANCE PROPERTY/REFINANCING OF LOANS

On the motion by Donald Cullum, and by an affirmative vote of all present, to discuss whether or not the discussion of a potential real estate purchase; nuisance property issues involving potential litigation; and the hiring of outside legal counsel for the proposed refinancing of bonds meet the qualifications for executive session.

On the motion of Donald Cullum, seconded by Craig Sanders, and by an affirmative vote of all present to go into executive session to discuss a potential real estate purchase; nuisance property issues involving potential litigation; and the hiring of outside legal counsel for the proposed refinancing of city bonds.

Present in executive session were Mayor Smith, Aldermen Clark, Cullum, Glidewell and Sanders, City Clerk Mary Parker, and City Attorney Chris Evans. A discussion was held regarding a potential real estate purchase; nuisance property issues involving potential litigation; and the hiring of outside legal counsel for the proposed refinancing of city bonds.

On the motion of Scottie Clark, seconded by Donald Cullum, and by an affirmative vote of all present to go out of executive session and into regular session.

Real estate discussion – no action taken.

On the motion of Scottie Clark, seconded by Donald Cullum, and by an affirmative vote of all present to amend the agenda to remove the nuisance property discussion and to add Teresa Wright water bill to agenda.

On the motion of Craig Sanders, and seconded by Scottie Clark, and by an affirmative vote of all present to adjust Talesha Wright's water bill in the amount of \$515.80 for water that leaked onto the ground because our employees looked at the meter where it was leaking and thought that it was leaking on our side when in fact it was on the customer's side charging her for 52,840 gallons of water that she did not use. Ms. Wright called to ask that the leak be checked and wanted the water turned off but was told the leak was not on her side. The board finds that this adjustment is allowed under state law due to the fact that the customer did not receive the benefit of the utility services provided.

On the motion of Craig Sanders, seconded by Donald Cullum, and by an affirmative vote of all present to continue working with Jones Walker to potentially refinance certain city bonds.
