RE: REQUEST TO REZONE HWY 145

On the motion of Terry Glidewell, seconded by Donald Cullum, and by an affirmative vote of all present to rezone parcel number 054G-17-018-01, located off Highway 145 (near the cell tower south of Elite Physical Therapy) from that of Mixed-Use (MX) to Commercial (C-2). The public hearing was noticed in accordance with the city zoning ordinance and state law, which took place October 2, 2018 at 5:30 PM at Saltillo City Hall. No one objected to the request at either the public hearing or the regular meeting and the board finds that the proposal is reasonable and allowed by law. The written ordinance will be published in accordance with state law and will go into effect in 30 days.

RE: WATER UPDATE

Mayor Smith gave a water update to those in attendance. Since, the vote was taken in July to switch the whole town to river water several things have had to take place. Engineering of the project had to be done, bids had to be published and opened. Once the city had a better estimate of the cost to switch over which now appears to be over \$180,000 instead of the \$114,000 that was first proposed. We now have to send our proposed rates to the PSC who has control over rates for those customers outside one mile of the city limits. The city is working diligently on getting everything in place to make the switch as soon as all things fall in place to do so.

RE: EMINENT DOMAIN

On the motion of Terry Glidewell, seconded by Donald Cullum, and by an affirmative vote of all present to proceed with the eminent domain by instructing the clerk to write a check in the amount of \$2238.05 to the County Court of Lee County for 85% of the appraised value of the property to be taken. Once this deposit has been made with the court, an immediate easement will be granted to the city in order that the ongoing water project can be completed as soon as possible.

The good samaritan clinic provides beneficial social and community service programs and receives grant money in order to operate and this donation is allowed by law as a partial match for the said grant money as allowed under MCA 21-19-65.
