RE: KEVIN WHITE – TIGER CREEK DISC GOLF

On the motion of Brian Morgan, seconded by Scottie Clark and by an affirmative vote of all present to approve up to \$8,000.00 for the purchase of steel disc golf baskets and concrete to build a disc golf course on the city wetland property across from the sportsplex. Bids were received from Dynamic Discs for \$5,430.00 and Prodigy for \$6,205.00 for the baskets and related materials. Bids were received for concrete from MMC for \$2,160.00 and B & B Concrete for \$2,174.00. Upon verification of the quotes, the baskets will be purchased from Dynamic Discs and the concrete from MMC as the lowest and best quotes. Local volunteers will assist in the design of the course and the installation of the items. All assets and the course itself will be the property of the city and will be under the full control of the city and the city park and recreation department.

RE: ADOPT TAX MILEAGE RESOLUTION

On the motion of Craig Sanders, seconded by Brian Morgan, and by an affirmative vote of all present to adopt the resolution setting the 2021-2022 Tax milage at 27 mils. General Revenue purposes: 23.6 mils; fire protection purposes: 2 mills; and General Obligation Refunding 2008 Bond and Interest: 1.4 mills. This represents no change from the prior tax year.

RE: 2021 AUDIT SERVICES
