RE: WORKSHOP - FUTURE

The Mayor and Board of Aldermen met to discuss future plans for the city and issues that may need to be addressed in a workshop on February 21, 2023 at 5:00 PM. Alderman Scottie Clark brought up the issue of parking in the streets in subdivisions and the problems it causes for the flow of traffic along with emergency vehicles unable to enter the subdivisions. The city currently does not have an ordinance to address parking in the streets. Alderwoman Witcher spoke to the issue also and they both made suggestions of setting a no street parking at all policy or a policy setting certain hours that parking would be prohibited. Alderman Craig Sanders brought up street lights needed in several areas around the city. He mentioned the area from Mobile to the intersection of Kellum where there are no lights at all, but Cartwright has several in a row and is well lit until you get to the intersection going into city park. We may want to hire someone who could drive the city at night and determine where we could install or move lighting to be more effective. No action taken.
